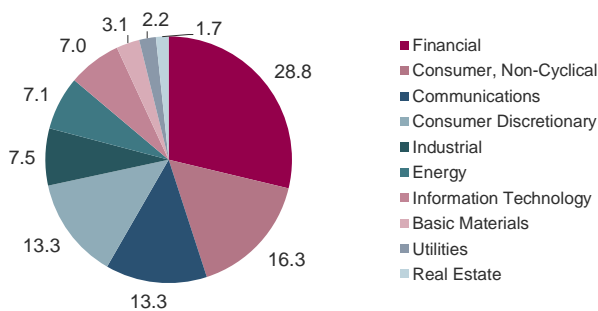
Investment Objective
